JFS IS PARTICULARLY WELL KNOWN FOR ITS PERSON-CENTERED AGING AND DISABILITY PROGRAMMING AND ITS COLLABORATIVE APPROACH TO MEETING THE NEEDS OF OUR MOST VULNERABLE ACROSS ALL SERVICE AREAS. AGING AND DISABILITY SERVICES, THE LARGEST SERVICE SECTOR, PROVIDED CASE MANAGEMENT AND SUPPORT TO 1,565 INDIVIDUALS AND FAMILIES TO ASSIST THEM TO CONTINUE LIVING INDEPENDENTLY.
